a. To consider the following planning applications

P/FUL/2024/00336 Change of use & conversion of barn to dwelling. 19 High Street Stalbridge Dorset DT10 2LH. Applicant: Harbridge Lanford Limited.

It was noted that previous granted application on the site had elapsed and that obscured glass had been included to address the issue of overlooking neighbouring properties. It was felt that due to the lack of windows on the south side, the small footprint and low ridge height of the barn it would be more suited to conversion as a one bedroomed annex.

<u>RESOLVED:</u> Proposed and agreed not to support the application in its present form. Whilst members appreciate that some development on the site to restore the current structure in the form of a small annex would be acceptable. They consider that this application is over ambitious in its scale which represents over development of the structure.

P/FUL/2023/07515 Erect 25 No. dwellings (including 10 No. first homes and 4 No. live/work units), form vehicular access, parking, public open space and related infrastructure. Land South Of The Paddocks Lower Road Stalbridge. Applicant: Mr Sam Briggs.
