Town Council Meeting Minutes

TOWLO report from J Wardell advised the procedure for reporting of emergency closures of footpaths. (link to report)

Mr Semple addressed the meeting and queried changes in the Town Councils plans for the jubilee event.

1. To receive apologies

2. To receive declarations of interest and requests for dispensations (Please notify the Town Clerk prior to the meeting)

K Garland: Pecuniary item 17a. in relation to payments to IK Services.

3. To approve the minutes of the meeting held on 16th February 2022

<u>RESOLVED:</u> The minutes of the meetings having previously been circulated to Councillors were approved and signed by the Chairman.

6. To receive the Dorset Councillors report.

G Carr-Jones expressed disappointment the application P/FUL/2021/03744 at Waterloo Lane had been granted to create a dwelling in the open countryside subsequent to part Q permission being established. He gave an update on Dorset Council actions in relation to the Ukrainian refugee situation. A written report had also been circulated to members.

7. To receive a report on conversations with the A357 group regarding HGV traffic.

P Hancock

P Hancock advised that he had met with the A357 Group in order to understand the effect that any prosed changes to HGV routes may have on Stalbridge. He also expressed concerns at the potential additional through traffic generated by the new developments in Stalbridge and Henstridge and from Poole in relation to more ports being utilised as a result of Brexit. He was keen to engage with the Stalbridge community to gain their opinion on the issue and explore the use of section 106 funds to improve the highway infrastructure in the town.

RESOLVED P Hancock to meet with DC highways officers to consider potential options

8. To receive a report from the Rights Of Way Liaison Officer regarding the issue of dog fouling on the trailway.

J Wardell had attended a site visit to bridleway 75 from its junction with Jarvis Way to the 'crossroads' of footpaths 69 and 34, and the Trailway with Cllr David Andrews following the receipt by the Clerk of correspondence regarding an increase in dog-fouling, and depositing of bags, near the access to the new development (Blackmore Meadows.). Possible sites for dog bins were noted, should TC decide that any more were needed. A map was provided showing the existing locations in the general area, and the distances between those and potential sites. It was noted that (excluding the 'dead-end' section of Trailway), the furthest distance to walk for a dog-bin is about 540 yards/490 metres. (link to report)

RESOLVED: To increase publicity to pick up in the area and monitor the situation.

9. To have a new poster campaign in areas where dog fouling has increased. K Garland

K Garland explained that in addition to the trailway their appeared to be an increased in dog fouling adjacent to Anglesey cottages and on the high street. She felt that it was an appropriate point to relaunch a publicity campaign to encourage dog owners to be aware and pick up.

G Carr Jones suggested providing bag dispensers that could be sponsored by local businesses. Involving the school was also suggested.

RESOLVED: To have a new poster / publicity campaign in areas where dog fouling has increased

10. In common with many other Towns and cities, to consider how Stalbridge should show solidarity with Ukraine and give further instruction.

K Garland

K Garland advised that the creative have offered to make sunflowers (Ukraine national flower) and put them around the town .

RESOLVED: To support the Creative sunflower project and offer a budget of £100 for materials if required

11. To consider forming a new part of the trailway from Station Rd North towards Henstridge and give further instruction.

S Waite

S Waite explained the motives of his proposal and the potential use of section 106 funds. J Wardell advised that the DC senior ranger is responsible for negotiation with land owners and as the emerging Dorset plan notes the trailway as a strategic resource to the area it will be built into any future planning obligations.

<u>RESOLVED</u>: J Wardell to arrange a meeting with the DC Senior Ranger to consider forming a new part of the trailway from Station Rd North towards Henstridge. To be attended by S Waite, J Wardell & G Carr-Jones.

12. To carry out a review of the Hub terms of letting and give further instruction.

<u>RESOLVED</u>: Delegated to K Garland H Hatcher & P Hancock to bring recommendations back to future TC meeting.

13. To approve the appointment of the internal auditor for 2021/2022 accounting period and review the terms of reference and schedule for the internal audit.

The Clerk advised that the previous internal auditor has left the area and she had approached J Wardell who is interested in taking this on.

<u>RESOLVED</u>: J Wardell appointed as internal auditor for 2021/2022 accounting period and the terms of reference and schedule for the internal audit approved
