It was previously resolved at the meeting 05.06.2019 to grant the Dispensations for all Councillors to allow them to discuss and vote on the setting of the Precept to apply until May 2024.

8. To consider the grant applications for the budget period 20/21 and give further instruction.

It was noted that the 20.21 Youth Club grant had been allocated in general reserves for the 21.22 period, pending the club being able to re-open.

Applications received from:

Stalbridge Playingfileds Trust For: Grounds / buildings upkeep & public liability insurance

Amount: £2,500

<u>RESOLVED:</u> Proposed an agreed to award a grant of £2,500 to the Stalbridge Playingfileds Trust for the period 21.22 for the upkeep of grounds & buildings and to cover the public liability insurance.

M Robinson queried the increased electricity cost for 19.20. Clerk to clarify

R Roden & M Robinson abstained from the vote.

#Willdoes project For: Mobile provision of youth services

Amount: not specified

Members felt this project was too far away to benefit Stalbridge and that the Town Council already supports the provision of Youth Services in Stalbridge.

St Marys PCC Churchyard grass & hedge cutting

Amount £5,100.00

In his role as Church Warden's Waite explained that due to the nature of the job it is very difficult to find reliable and dependable contractors who are interested in the mowing contract for the Church yard and the PCC had not bee able to provide any quotes for members review. Therefore he had

submitted an application with a 2% increase on the 20.21 grant and if there is any shortfall this will have be met by the Church.

**RESOLVED**: To make the following grants for the budget period 21/22:

• Playingfields Management Committee £2,500 for building and grounds maintenance and public liability insurance.

R Roden & M Robinson abstained from the Vote

St Marys PCC £5,100 for the period 21.22 for the Churchyard grass & hedge cutting.

S Waite abstained from the vote.

9. To consider the figures presented for the budget period 21/22 in forecast income and give further instruction.

<u>RESOLVED:</u> There was general agreement to accept the figures presented for the Budget period 21/22 in forecast income excluding the precept.

10. To consider the figures presented for the budget period 21/22 forecast payments and give further instruction.

<u>RESOLVED:</u> There was general agreement to accept the figures presented for the Budget period 21/22 forecast payments.

11. To resolve the level of the precept 2021/2022.

It was noted that the tax base figure had reduced therefore the charge for those paying full Council tax had increased. The previously reviewed forecast income and expenditure was considered in relation to the tax base precept toolkit which illustrated the effect of any precept increase on a Band D Equivalent Charge.

<u>RESOLVED:</u> It was proposed and agreed to make a precept demand for the period 21/22 of £126,500 a zero increase in value, which equates to an increase of £1.61 pence per annum or 16 pence per month over the ten month charging period on a Band D Equivalent Charge for the TC's part of the council tax.
