c. 2/2020/1246/VARIA Removal of condition 4 of planning permission 2/1988/0914 and condition 1 of planning permission 2/2001/0597 - to remove occupancy restriction condition. Foxlea Farm Drews Lane Stalbridge Dorset DT10 2LU. Mr J &Mrs S Turner

Members were divided in their initial opinions of the application. Whilst some members felt that there was little point in having conditions on applications if they can just be removed at a later date, others could see no reason that the condition should stand and a suggestion was made to defer to the Planning Officer.

<u>RESOLVED</u>: Proposed and agreed not to support the application as without the agricultural / equestrian condition the house would never have been permitted.
