## **Proposed Youth Shelter in Stalbridge**

The Chairman asked the members of the public if they had a spokesperson - no. Those members of the public present were under the impression that the discussion was to be about a Shelter on the JFPA, and several spoke voicing their opposition. The Chairman stated that was not what was on the agenda, and that that suggestion had been voted against in December. We were here to discuss the principal of a Youth Shelter. Several members of the public again stated that there were problems in the JFPA, because of youngsters with drink, and noise nuisance etc. PC Phil Sugrue was asked about other Youth Shelters in his area, and commented favourably on those at Hazelbury Bryan and Stourton Caundle. A member of public (lady) asked why they couldn't use Youth Club, why volunteers couldn't run it etc. Bob Penfold answered - not enough hours provided by youth service. After more comments about vehicles and drinking etc, the Chairman pointed out that the Youth Shelter was intended for youngsters in the rough age range of 14-16, who would not be driving. He was concerned that there seemed to be an 'antiyouth' feeling, whereas there were only a few who unfortunately caused problems. He then asked Councillors individually and all were in favour in principle, with provisos that siting, up-keep, and funding were fully discussed. Those young people present commented that if they were involved in the construction of such a shelter, then they would feel responsible for it, and it would not be 'trashed'.

On the matter of problems at JF Play area, the police can only do something if they are informed. Information leaflets were given out.

It was proposed that the item of the Youth Shelter be put on the Agenda as a 'rolling' item, by John and seconded by Des Grimes. Carried Unanimously.

# Consider Town Council's response to comments on proposed Traffic Calming Scheme

The Chairman went through the history of the parking restrictions in the High Street and explained that as a result of the request for a Pedestrian Crossing being refused the DCC Highways had produced the scheme to replace the single yellow lines in the High Street with double but at the same time provide a limited time waiting area between 8 a.m. and 6 p.m. outside the Newsagents and Hairdressers. They felt that this would help alleviate the problem with heavy lorries being unable to pass each other without mounting the pavement due to illegal parking (motorists are more likely to take notice of the double lines) but loading and unloading and parking by disabled badge holders would still be able to take place. The Chairman then allowed those members of the public present to express their views, which were all against the proposed changes and included complaints that they had not been consulted. The Chairman pointed out that the matter had been put on various Agendas and discussed at various Council meetings which are always open to the Public. As a result it was agreed to hold a public meeting

and to invite a representative from DCC to attend and answer questions. Date to be arranged by the Clerk. It was also agreed to send the draft letter produced by the Clerk to the Blackmore Vale Magazine for publication, with the additional comment that the various planning applications that have been granted for developments on Henstridge Airfield would increase the heavy traffic through the High Street. All agreed. It was also pointed out that D Cllr Carr-Jones has already requested that this application be dealt with by the full Planning Committee. Copies of 7 letters of objection received.

No. 0025/0026 Stalbridge Arms. Various alterations. It was proposed by J Cowley and seconded by B Alexandre that objections as per attached list compiled by the P & GP Cttee be raised. 6 in favour, 1 abstention. However it was agreed to add that if the concerns raised in the list can be resolved to the satisfaction of the Town Council then they have no objection to the application being dealt with under delegated powers.

Sth Som. 05482. Site breeding tanks for worms. Henstridge Airfield. It was proposed by D Grimes and seconded by J Wardell that there be no objections. All agreed.

## **Award contract for Cleaning Toilets and Pavements**

After some discussion during which it was confirmed that the various items in the S L A referred to work in Zone 1 only i.e. from The Ring to the bottom of Church Hill and Station Road as far as the Car Park (a plan showing this area to be attached to the SLA) It was proposed by B Alexandre and seconded by D Grimes that the contract for the work be awarded to Gillingham Town Council for 20 hours only from Monday to Friday inclusive. Carried on a vote of 6 in favour 1 abstention.

It was also agreed to write to NDDC and point out that it is felt that the Business Rate of £2,400 p.a. approx. seems excessive for such a small building and that NDDC should continue to pay this as they will get part of it back from the Government in Grant. It was also agreed to request that NDDC bear the legal costs of the Town Council as they have forced the TC to do this work and to take on the lease of the Toilets rather than the TC asking to do it.

## Any other business

J Cowley reported that the pavement retaining wall in Park Grove adjacent the Dog Bin is crumbling.

There being no further business the meeting closed at 9-15 p.m.

#### Comments made by the Planning & General Purposes Committee

## Planning Application Numbers 0025/0026

Various Alterations – Stalbridge Arms

We object to the above applications, on the grounds that it is unclear whether adequate provision has been made for ventilation to/from the extended kitchen area, and whether that ventilation would impinge on the surrounding properties. We feel it essential that the kitchen exhaust fumes are not directed over the garden of the property to the rear

There are also concerns that the en-suite rooms will not be let out under normal Hotel conditions but let out on full-term residential basis.

We have reservations that as this is a listed building, these proposed alterations/developments might not conform to the appropriate regulations.

## Planning Application Number 2/2007/1349

Land to rear of Stalbridge Library – Erect 4 Dwellings

We object most strongly to the above application for the following reasons:

- 1) Due to the inadequacies of the highway network, Stalbridge is scheduled as a 'Town of Limited Growth'. The Town is already well over the number of housing units, as allowed for in the Districtwide Plan.
- 2) Part of this site has already been designated for the relocation of the recycling bins. Please see the attached correspondence between Mr Ritchie (Asset Management Consultant NDDC) and Stalbridge Town Council dated 14th May 2007. As the remainder of the site is urgently required for additional car parking spaces, it is an inappropriate use of the land: since the loss of the car park in Grove Lane, this site has been earmarked as a contingency car park, to provide much needed additional car parking spaces for those who come to Stalbridge to work, residents visiting the Library, Doctor's Surgery and Dental Surgery, parents taking children to school (because of the difficulty of parking elsewhere) and of course, visitors.
- 3) It is an overdevelopment of the site, and will be very intrusive for the residents of Hardy Crescent, the site being on a much higher level than Hardy Crescent.
- 4) It would be a development with an inherent danger: on the assumption that it will house families with young children, they would be a risk to, and at risk from traffic movements within the car park, as well as the increased traffic resulting from the Archstone development. The road directly in front of the proposed properties will in effect become a 'through' road.
- 5) The drainage to the properties is stated to be soakaways, which would exacerbate problems which already exist for properties in Hardy Crescent.
- 6) It is unacceptable to remove another tree within the Conservation area.

We consider it essential that this application goes before the full Development Control Committee.
