A suggestion was made that the TC carry out environmental assessments on all there resolutions / actions.

It was suggested that there is public consultation regarding item 6. The Clerk advised that this is part of the DC highways traffic regulation order process.

Tree Officer- Mentioned the problem of litter and human waste on The trailway. Ref item 10. The 2 oaks are splendid specimens and would support a TPO. A question was raised at to which trees have a TPO on them in Stalbridge. Clerk to advise. Offered some native saplings that can be planted on the trailway side of the fence at Jarvis field play area.

L Lovell - Suggested making an enquiry with DC highways regarding the removal of a section of hedge at Lower Rd before the Bovis site.

B Penfold – Poor service form SEE on the works at Barrow Hill. The clerk advised she had been in constant contact with DC Highways and there is an option to issue a fine for the delay in completing the works.
