There were 10 members of the public in attendance.

Apologies had been received from G Carr-Jones (North Dorset Dist. & DC Cllr.) W Batty-Smith (North Dorset Dist. Cllr.)

Welcome to members of the public and introductions.

1. Community open forum.

A question was asked with regard to permission for tree works. Advice was given to refer to NDDC Planning.

A question was raised as to why the Lower Rd & Thornhill Rd application decisions had not been reported at the Planning Meeting.

J Wardell advised that as the applications were granted there would be some further work on conditions and for this reason the decision notices had not been issued yet.

Members of the public noted that there were two members of Stalbridge TC present at the NDDC planning meeting 27.02.18, who spoke on the applications as Ward Member and Ramblers Representative, but there was not a member of Stalbridge TC present to make representation on behalf of the TC. Disappointment was expressed at this situation and members were asked the reason for this.

K Garland sincerely apologised on behalf of the Town Council and passed the question to J Cowley, who she had understood had committed to attending the meeting. J Cowley read out a statement explaining the reason that he had not attended the meeting on behalf of the Town Council (Addendum to minutes). Members agreed that a member of the Town Council should have been in attendance and made representation, however due to a breakdown in communication there had not been the opportunity for another member to attend in J Cowleys place.

Members of the public felt that the Chairman may have a conflict of interest in having multiple roles in local Government and that Stalbridge should be put first.

The Clerk advised that the comments made by The Town Council made up part of the Committee report and that the Chairman had made it implicitly clear to the TC on three occasions that he would be speaking as Ward Member and had asked for other members to commit to representing Stalbridge TC. She also advised that the role of Chairman does not convey any special powers over and above other members other than a casing vote when a vote is tied.

C Moore pointed out that it is a TC member's duty to make democratic representation, regardless of the final resolution differing from their personal views

Members of the public expressed further concerns at the way in which the NDDC meeting had been carried out with particular reference to the behaviour of the DCC Highways Officer.
