It was understood that in order for the Town Council to support the project and become the accountable body they need to join up to the DC Highways working together agreement. Currently highways verge maintenance is a statutory duty of Dorset Council Highways as the as the principal authority. If the TC join up to the working together agreement they become an agent who is empowered to exercise on behalf of the Principal, powers of the Principal as highway and traffic authority. In carrying out these duties the agent must conform to legislative requirements, current specifications, personnel training, health and safety and insurance.

The agreement is subject to a formal annual review and termination is based on either party giving a minimum of six months' written notice. Some concerns were expressed at personal injury cover for volunteers. It was agreed that a schedule of areas works and the appropriate risk assessment would need to be drawn up.

<u>RESOLVED</u>: Proposed and agreed that the Town Council sign the DC Highways working together agreement in relation to the wild flower planting on highways verges subject to further negotiation with DC Rangers and Highways on the detail of the agreement.
